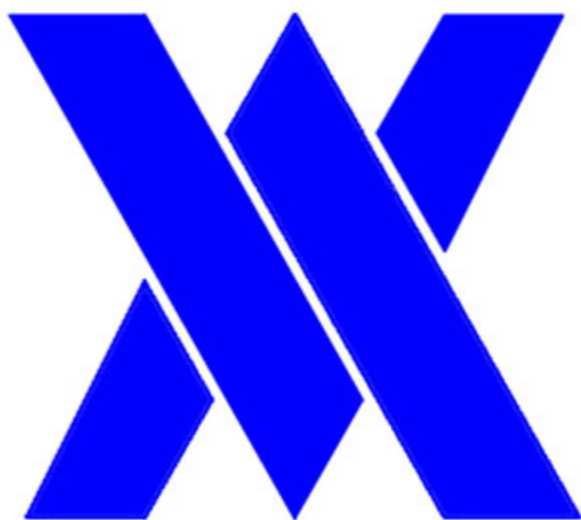

VAALCO Reschedules Its Third Quarter 2015 Earnings Release And Conference Call
